### **Description of Design Change:**

Installation of an Avionica, Inc. avWiFi wireless router system

The system provides 3 modes of operation installations: Secure device to device Wi-Fi Wireless connectivity in the aircraft cabin during all phases of flight (CWLU Mode), or WiFi connectivity to the Gate Terminal WiFi Router on the ground via an external antenna (TWLU Mode), or both (TWLU and CWLU Mode). Cabin WiFi CWLU installation includes a flight deck Wi-Fi On/Off guarded toggle switch. The avWiFi unit is installed in one of these location configurations: On the avRDC or avRDC MAX Quick Access Recorder (QAR), or near the MK-II or MK-III miniQAR, or in the cabin, or in the Avionics Bay.

#### **Limitations/Conditions:**

The avWiFi system must be deactivated via the flight deck WiFi switch during Autoland landing on the B777.

Refer to limitations in Airworthiness Directive AD 2014-20-06 and Policy Statement PS-ANM-25-13; this WiFi installation is not compatible with B777 and B737NG aircraft equipped with Honeywell Phase III CDS displays, since WiFi can cause interference with these displays.

Prior to installation of this design change it must be determined that the interrelationship between this design change and any other previously installed design change and/ or repair will introduce no adverse effect upon the airworthiness of the product.
