This approval should not be extended to other aircraft of this model on which other previously approved modifications are incorporated, unless it is determined by the installer that the interrelationship between this change and any other previously approved modifications, including integration to other Archeion STC's, will produce no adverse effect upon the airworthiness of that airplane.
